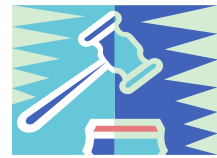

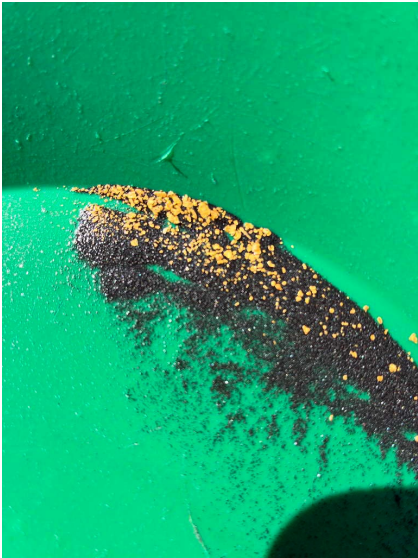

OUTTING Information

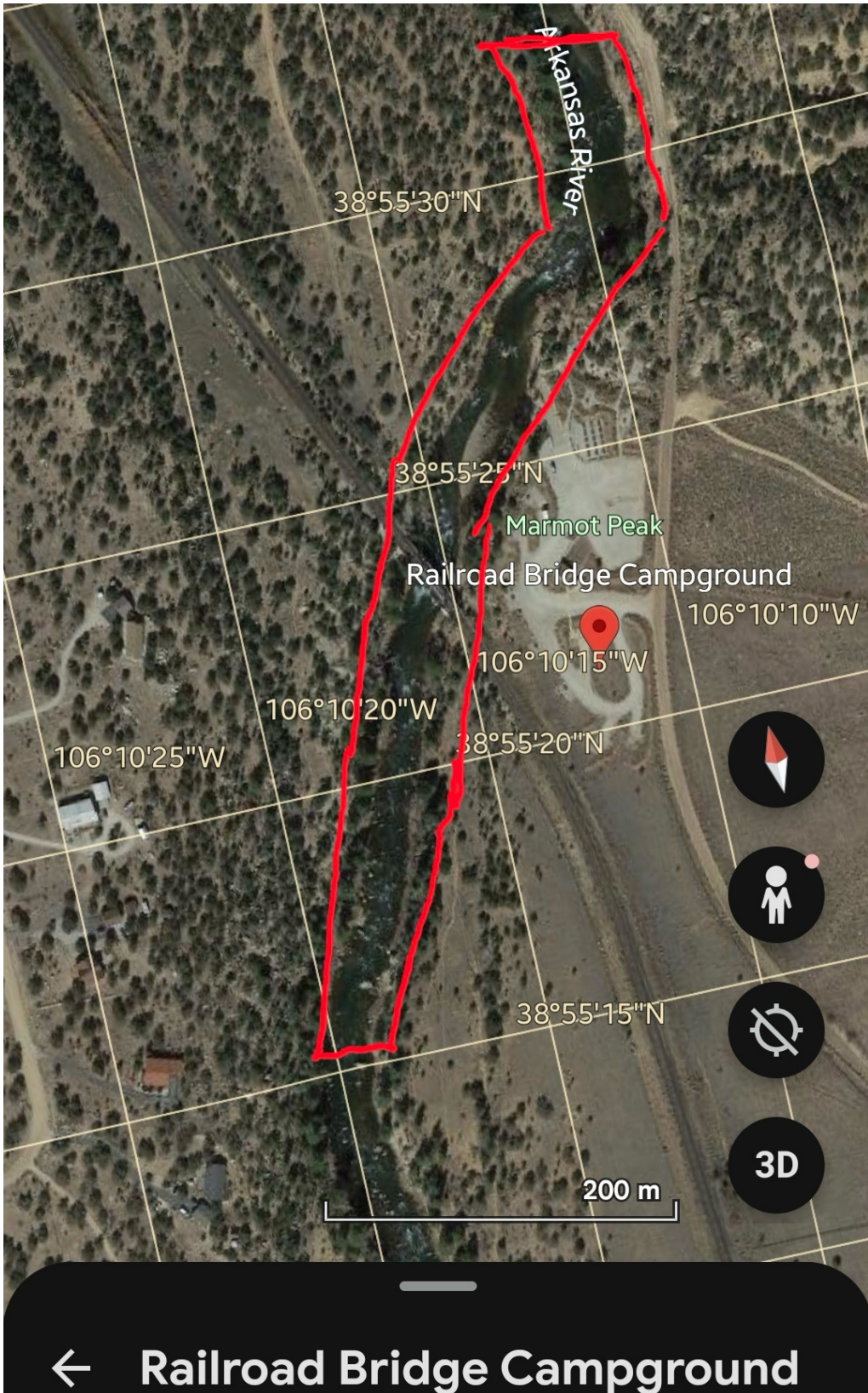
